the transnationally coordinated response to covid 19 witnessed numerous developments reminiscent of the prewar years of the third reich including the suspension of constitutional rights and freedoms the rollout of draconian legislation an attempted revolution from above the great reset the censorship of dissent health surveillance euthanasia eugenics the corruption of science by politics and the hijacking of conscience the list goes on never again was the rallying cry after 1945 yet never again is now global how did we get here wall street the nazis and the crimes of the deep state explores the role of wall street in promoting the rise of hitler funding the nazi war machine recruiting and rehabilitating ex nazis and creating a transnational deep state inspired by nazi methods wall street has long preferred totalitarianism as the regime type most effective in crushing working class resistance and as capitalism once more enters a period of acute crisis the aim is to replace liberal democracy with global technocracy a novel biodigital form of totalitarianism whose potential for social control exceeds anything imaginable by hitler or stalin wall street the nazis and the crimes of the deep state illustrates how totalitarianism does not spring into

existence fully formed in the case of nazi germany the descent into barbarism took place gradually over many years today the warning signs from history are flashing red unless the global technocratic coup being attempted is put down we can expect the centralization of power in a new world order the return of slavery the privatization of the global commons and the transformation of society into a biodigital camp bringing an end to the rule of law and normalizing the use of eugenics and a systematic mass murder of dissidents

this first comprehensive analysis of the third reich s efforts to confiscate loot censor and influence art begins with a brief history of the looting of artworks in western history the artistic backgrounds of adolf hitler and hermann goring are examined along with the various nazi art looting organizations and nazi endeavors to both censor and manipulate the arts for propaganda purposes long held beliefs about the nazi destruction of degenerate art are examined drawing on recently developed university databases new translations of original documents and recently discovered information theft and destruction of artworks by the allies and looting by soviet trophy brigades are also documented

how much did american protestants know about the nazi persecution of european jews before and during world war ii very little many of them claimed in the postwar years robert w ross challenges that answer in this analysis of the ways in which protestant journals ranging from the christian century to the arkansas baptist reported and editorialized on the subject from 1933 through 1945

while we often tend to think of the third reich as a zone of lawlessness the nazi dictatorship and its policies of persecution rested on a legal foundation set in place and maintained by judges lawyers and civil servants trained in the law this volume offers a concise and compelling account of how these intelligent and well-educated legal professionals lent their skills and knowledge to a system of oppression and domination the chapters address why german lawyers and jurists were attracted to nazism how their support of the regime resulted from a combination of ideological conviction careerist opportunism and legalistic self-delusion and whether they were held accountable for their nazi era actions after 1945 this book also examines the experiences of jewish lawyers who fell victim to anti-semitic measures the volume will appeal to scholars students and other readers with an interest in nazi germany the holocaust and the history of jurisprudence

when hitler published *mein kampf* in 1924 he held up a foreign law as a model for his program of racial purification the u s immigration restriction act of 1924 which prohibited the immigration of those with hereditary illnesses and entire ethnic groups when the nazis took power in 1933 they installed a program of eugenics the attempted improvement of the population through forced sterilization and marriage controls that consciously drew on the u s example by then many american states had long had compulsory sterilization laws for defectives upheld by the supreme court in 1927 small wonder that the nazi laws led one eugenics activist in virginia to complain the germans are beating us at our own game in the nazi connection stefan kühl uncovers the ties between the american eugenics movement and the nazi program of racial hygiene showing that many american scientists actively supported hitler's policies after introducing us to the recently resurgent problem of scientific racism kühl carefully recounts the history of the eugenics movement both in the united states and internationally demonstrating how widely the idea of sterilization as a genetic control had become accepted by the early twentieth century from the first the american eugenicists led the way with radical ideas their influence led to sterilization laws in dozens of states laws which were studied and praised by the german racial hygienists with the rise of hitler the germans enacted compulsory sterilization laws partly based on the u s experience and american eugenicists took pride in their influence on nazi policies kühl recreates astonishing scenes of american eugenicists travelling to germany to study the new laws publishing scholarly articles lionizing the nazi eugenics program and proudly comparing personal notes from hitler thanking them for their books even after the outbreak of war he writes the american eugenicists frowned upon hitler's totalitarian government but not his sterilization laws so deep was the failure to recognize the connection between eugenics and hitler's genocidal policies that a prominent liberal jewish eugenicist who had been forced to flee germany found it fit to grumble that the nazis took over our entire plan of eugenic measures by 1945 when the murderous nature of the nazi government was made perfectly clear the american eugenicists sought

to downplay the close connections between themselves and the German program some of them in fact had sought to distance themselves from Hitler even before the war but Stefan Kühl's deeply documented book provides a devastating indictment of the influence and aid provided by American scientists for the most comprehensive attempt to enforce racial purity in world history

Armed with jokes puns and cartoons Norwegians tried to keep their spirits high and foster the resistance by poking fun at the occupying Germans during World War II despite a 1942 ordinance mandating death for the ridicule of Nazi soldiers Norwegians attacked the occupying Nazis and their Norwegian collaborators by means of anecdotes quips insinuating personal ads children's stories Christmas cards mock postage stamps and symbolic clothing in relating this dramatic story Kathleen Stokker draws upon her many interviews with survivors of the occupation and upon the archives of the Norwegian Resistance Museum and the University of Oslo Central to the book are four joke notebooks kept by women ranging in age from eleven to thirty who found sufficient meaning in this humor to risk recording and preserving it Stokker also cites details from wartime diaries of three other women from East West and North Norway placing the joking in historical cultural and psychological context Stokker demonstrates how this seemingly frivolous humor in fact contributed to the development of a resistance mentality among an initially confused paralyzed and dispirited population stunned by the German invasion of their neutral country for this paperback edition Stokker has added a new preface offering a comparative view of resistance through humor in neighboring Denmark

No one better represents the plight and the conduct of German intellectuals under Hitler than Werner Heisenberg whose task it was to build an atomic bomb for Nazi Germany the controversy surrounding Heisenberg still rages because of the nature of his work and the regime for which it was undertaken what precisely did Heisenberg know about the physics of the atomic bomb how deep was his loyalty to the German government during the Third Reich assuming that he had been able to build a bomb would he have been willing these questions the moral and the scientific are answered by Paul Lawrence Rose with greater accuracy and breadth of documentation than any other historian has yet achieved digging deep into the archival record among formerly secret technical reports Rose establishes that Heisenberg never overcame certain misconceptions about nuclear fission and as a result the German leaders never pushed for atomic weapons in fact Heisenberg never had to face the moral problem of whether he should design a bomb for the Nazi regime only when he and his colleagues were interned in England and heard about Hiroshima did Heisenberg realize that his calculations were wrong he began at once to construct an image of himself as a pure scientist who could have built a bomb but chose to work on reactor design instead this was fiction as Rose demonstrates in reality Heisenberg blindly supported and justified the cause of German victory the question of why he did and why he misrepresented himself afterwards is answered through Rose's subtle analysis of German mentality and the scientists' problems of delusion and self-delusion this fascinating study is a profound effort to understand one of the twentieth century's great enigmas no one better represents the plight and the conduct of German intellectuals under Hitler than Werner Heisenberg whose task it was to build an atomic bomb for Nazi Germany the controversy surrounding Heisenberg still rages because of the nature of his w

early in his career hitler took inspiration from mussolini this fact is widely known but an equally important role model for hitler has been neglected atatürk the founder of modern turkey who inspired hitler to remake germany along nationalist secular totalitarian and ethnically exclusive lines stefan ihrig tells this compelling story

the nazi study of india and indian anti colonialism is the first detailed and critical study of the intellectual and political connections that existed between some german scholars specializing on india non academic india experts indian anti colonialists and various organs of the nazi state it explores the ways in which different knowledge discourses pertaining to india particularly its colonization and the anti colonial movement were used by these individuals for a number of german organisations to fulfil the demands of nazi politics this monograph also inspects the links between the knowledge providers and embodiments of national socialist politics like the nazi party and its affiliates in this study baijayanti roy aims to ascertain whether such political engagements were actually more rewarding for the scholars than their practical services to the state in the form of strategic deployment of their knowledge of india the nazi study of india and indian anti colonialism offers case studies of four organisations which incorporated such complicated entanglements of knowledge and power the india institute of the deutsche akademie in munich the special department india of the german foreign ministry the seminar for oriental languages and its successor institutions at the university of berlin and the indian legion of the german army the knowledge networks underlying these organisations were dominated by german indologists but non specialist knowledge providers both german and indian were also included the nazi regime expected all scholars and intellectuals to engage in kulturpolitik cultural politics which entailed propagating the glories of the reich and its supreme leader as well as collecting politically valuable knowledge within and outside germany for the four organizations concerned this meant conducting pro german and from around 1938 anti british propaganda aimed at indians loosely following an analogy provided by herbert mehrtens in the context of natural sciences this monograph posits that there were patterns of collaboration between the knowledge providers and the representatives of the nazi regime at the core of these patterns was to borrow mitchell ash s theory an exchange of resources and capital in which scholars and experts offered their knowledge of indian languages history and culture to authorities like the foreign ministry the ss and the army in return they received increased professional opportunities financial remuneration or in some cases increased power and influence

awarded the german non fiction prize 2022 malinowski s work is a near masterpiece relating a story not synthesised in this way before and about which any number of self serving myths exist simon heffer the telegraph stephan malinowski s brilliant book strikes a balance between the forensic analysis of individual behaviour and a new understanding of how the toxic political culture of a defeated monarchy helped to disrupt democracy in germany christopher clark the shocking true story of the german monarchy s collaboration with the nazis already a bestseller in germany now in english for the first time the disappearance of the hohenzollern family from the history of germany in november 1918 as the kaiser fled into dutch exile is one of the most startling rapid instances of a once all powerful royal family becoming almost overnight irrelevant and marginal except this is not exactly what happened stephan malinowski s german bestseller is an extraordinary work of recovery it suited both the weimar republic and then the third reich to view the hohenzollerns with contempt and yet the royal

family's hatred of the former and approval of the latter were for millions of Germans a significant factor in their own view of their country and its government with forensic and often shocking detail Malinowski shows that far from being ridiculous marginal figures the Hohenzollerns lay at the heart of Germany's ongoing nightmare despite formally losing power the members of the royal family remained prominent catastrophically allowing many other conservative Germans to stay distanced from the new republic and to eventually betray conservative traditions and values battered from both left and right the republic collapsed in 1933 in part because conservative forces fearful of both communism and fascism had abandoned their own principles just as much as the leading members of former royal family had who were themselves beguiled by and fooled by Hitler this is an important and shocking book as well as a devastating picture of an inadequate and trivial royal family painfully underequipped to fulfil its role

Hitler and Nazi Germany provides a concise introduction to Hitler's rise to power and Nazi domestic and foreign policies through to the end of the second world war combining narrative the views of different historians interpretation and a selection of sources this book provides a concise introduction and study aid for students this second edition has been extensively revised and expanded and includes new chapters on the Nazi regime the SS and Gestapo and the second world war expanded background narratives provide a solid understanding of the period and the analyses and sources have been updated throughout to help students engage with recent historiography and form their own interpretation of events

Detlef Mühlberger's work *Hitler's Voice: The Völkischer Beobachter 1920-1933* is an important addition to the study of national socialism in today's scholarship it is difficult to locate a detailed work on national socialism that does not rely in some way on the *Völkischer Beobachter* it was truly the bullhorn of the party from the time when the national socialists were no more than a small group of unknowns gathering at the Munich Bürgerbräukeller until they gained power in 1933 considering the vast amount of literature on national socialism however it is surprising that until now there have only been shorter articles and two dissertations and not a single comprehensive analysis of the newspaper 1 Mühlberger's translation of articles from the *Völkischer Beobachter* addresses this lacuna he has sifted through eleven years of the paper condensing them into two volumes his first volume gives a chronological account of the development and organization of the party until 1933 while the shorter second volume entitled *Nazi Ideology and Propaganda* examines topical issues such as attacks against the Weimar Republic racism and attempts by the party to garner support from workers farmers and the German Mittelstand

contemporaries and historians have found it difficult to interpret the ambiguous relationship between national socialism and christianity both the catholic and protestant churches tended to agree with national socialists in their authoritarianism their attacks on socialism and communism and their campaign against the versailles treaty but the doctrinal position of the churches could not be reconciled with the principle of racism a foreign policy of unlimited aggressive warfare or a domestic agenda involving the complete subservience of church to state important sections of the nazi party sought the complete extirpation of christianity and its substitution by a purely racial religion but considerations of expediency made it impossible for the national socialist leadership to adopt this radical anti christian stance as official policy the kulturkampf newsletters which have not appeared in english since the 1930s were produced by german catholic exiles in france they scrupulously document the tensions between various strands of nazi policy and the nature of the policy eventually adopted this was to reduce the churches influence in all areas of public life through the use of every available means yet without provoking the difficulties diplomatic as well as domestic which an openly declared war of extermination might have caused
