over the last two decades the israeli government has implemented policies for the development of east jerusalem these comprise urban revitalization as well as professional training and the promotion of entrepreneurship for the palestinians but how do these policies co exist under israeli settler colonial power this book focuses on the contradiction between the rise of neoliberal development in east jerusalem and the simultaneous continuation of israeli settler colonialism it argues that the combination of settler colonialism and neoliberalism allows for the primitive accumulation of capital to also occur permanently through deceptive soft forms more than this based on theoretical research interviews and an analysis of race and class relations in east jerusalem the book shows that neoliberal development is used to facilitate the reproduction of racial hierarchies settler privileges and the pacification of the palestinian residents where these outcomes are presented as the natural result of market relations the author calls this environment neoliberal settler colonialism and explores palestinians new acts of resistance that exist ambivalently within this structure a significant theoretical contribution the study highlights a new settler colonial and neoliberal sociability that co opts the exploited and oppressed

during the last decade of the british mandate for palestine 1939 1948 arabs and jews used the law as a resource to gain leverage against each other and to influence international opinion the parties invoked transformational legal framing to portray the essentially political religious conflict as a legal dispute involving claims of justice injustice and victimisation and giving rise to legal equitable remedies employing this form of narrative and framing in multiple trials during the first 15 years

of the mandate the parties continued the practice during the last and most crucial decade of the mandate the term trial provides an appropriate typology for understanding the adversarial proceedings during those years in which judges lawyers witnesses cross examination and legal argumentation played a key role in the conflict the four trials between 1939 and 1947 produced three different outcomes the one state solution in favour of the palestinian arabs the no state solution and the two state solution embodied in the united nations november 1947 partition resolution culminating in israel s independence in may 1948 this study analyses the role of the law during the last decade of the british mandate for palestine making an essential contribution to the literature on lawfare framing and narrative and the arab israeli conflict

the quest for an inclusive and independent state has been at the center of the palestinian national struggle for a very long time this book critically reexamines this quest by exploring the meaning of palestinian statehood and the challenges that face alternative models to it today rethinking statehood in palestine gives prominence to a young set of diverse palestinian scholars both men and women to show how notions of citizenship sovereignty and nationhood are being currently rethought within the broader context of decolonization bringing forth critical and multifacetted engagements with what palestinian self determination entails within a larger regional context this groundbreaking book sets the terms of debate for the future of palestine beyond partition

this work focuses on the political philosophy and the constitutional transformation of the contradiction between two major nations in one land namely palestine israel while the notion of the nation state has permeated the levant since the 1917 british crusade into jerusalem the organic demographic actuality of the country s population is incompatible with the dominance of one nation in one land with the subsequent degeneration into the series of war crimes that began in 1947 to move away from this conception of a zionist state requires another methodology that offers an alternative to the

domination of one nation by another that is rationalized by the myths of nation building promoted by the nationalist school of thought with an approach that is international in the root meaning of the term this book fuses the jewish bundist concept of national cultural autonomy with the process of constituent assemblies as an expression of the parallel civil societies that become an organic social construction codified in a federal constitution by avoiding the notion of the nation state this exit may then be named the no state solution

encountering palestine un making spaces of colonial violence edited by mark griffiths and mikko joronen sits at the intersection of cultural and political geographies and offers innovative reflections on power colonialism and anti colonialism in contemporary palestine and israel organized around the theme of encountering and focusing on the ways violence and struggle are un made in the encounter between the colonizer and colonized the essays focus on power relations as they manifest in cultural practices and everyday lives in anti colonial palestine covering numerous sites in gaza the west bank east jerusalem and israel encountering palestine addresses a range of empirical topics from marriage and queer aesthetics to policing demolition armament failure and violence the contributors utilize diverse theoretical frameworks such as hyperreality settler capitalism intimate biopolitics and politics of vulnerability to help us better understand the cultural making and unmaking of colonial and anti colonial space in palestine encountering palestine asks us to rethink how colonialism and power operate in palestine the ways palestinians struggle and the lifeways that constantly encounter un make and counter the spaces of colonial violence

when do words and actions empower when do they betray based on ethnographic fieldwork this volume tracks the repercussions of advocacy activism against house demolitions in unrecognised arab bedouin villages in israel s southern internal frontier it highlights the repercussions of activism for victims fund raisers and activists the ethnographic episodes

show how humanitarian aid intervention and indigenous identity politics can turn into a double edged sword ironically institutional lobbying for coexistence and its interpretative categories can sometimes perpetuate different forms of subjugation the volume also shows how beyond the institutional lobbying novel figures of activism emerge informal networks create non sectarian cross cutting countercultures and rethink human environment relationships these experimental political subjects redefine the categories of the conflict and elude the logic of zero sum games they point towards a shifting paradigm in current ethnopolitics koensler outlines an ethnographic approach for the study of social movements that follows multiple relations around mobilisations rather than studying activism in itself this perspective thus becomes relevant for scholars and activists engaged with the israeli palestinian conflict and those interested in global rights discourses

examining how memory intergenerational transmission and kinship work together relative strangers sheds light on romani life in palestine arpan roy presents an ethnographic portrait of dom romani communities living between palestine and jordan zooming in on everyday life in working class neighborhoods and under conditions of perpetual war and instability the book focuses on how doms are able to sustain ethnic difference through kinship even when public performances of difference are no longer emphasized a kind of alterity that is neither visible by obvious markers like race or religious difference nor detected by the antennas of the state drawing on long term ethnographic fieldwork in jerusalem ramallah and amman roy makes a case for such alterity for romani people and other groups in the region analysing intimate ethnographic scenes through anthropological theories of kinship psychoanalysis social theory from the global south and more the book reveals how alterity in the middle east does not adhere to rigid identitarian categories ultimately relative strangers demonstrates the inadequacy of transposing models of pluralism centred on european and american experiences of minoritization onto other contexts
